**First party:** The University of Jordan, Amman, 11942, Jordan, represented by its President or designated officer.

**Second party:** FRIEDRICH-SCHILLER UNIVERSITÄT Jena, Germany.

Whereas the two parties desire to develop academic cooperation in various fields, the two parties conclude this Memorandum of Understanding (MoU) and agree to the following:

In order to extend the effective and mutually beneficial cooperation and develop academic and cultural exchange in education, research and other areas, THE UNIVERSITY OF JORDAN, and THE FRIEDRICH-SCHILLER UNIVERSITÄT JENA, Germany hereby agree to cooperate toward the internationalization of higher education.

The areas of cooperation will include any program offered at either university, which aims to promote the abovementioned goals. However, any specific program shall be subject to mutual consent, availability of funds and the approval of both universities. Such programs may include:


- a) exchange of faculty members
- b) exchange of students (subject to terms to be outlined in a separate Exchange Agreement).
- c) exchange of publications
- d) joint research projects
- e) joint conferences
- f) joint teaching projects
- g) joint cultural programs

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the responsible authority of each university prior to the initiation of any particular program or activity.

This memorandum of understanding (MOU) shall take effect upon approval by both parties and shall remain in effect for an initial period of five years. The Memorandum may be amended or renewed only upon mutual written consent. However, either university may terminate the agreement in writing at least ten months prior to the beginning of an academic term/year.
