





Socially

Peace building is understood as a comprehensive concept that includes, generates and supports the full range of processes, approaches and phases needed to transform conflict into more sustainable and peaceful relationships. Hence, the term includes a wide range of activities that precede and follow formal peace agreements. Metaphorically speaking, peace is not seen merely as a phase of time or a condition. It is a dynamic social construct.

The program guarantees the preparation of qualified political cadres to promote Palestinian civil peace.

Qualifying academic cadres that promote concepts and practices of coexistence and internal reconciliation.

Preparing specialized graduates in the field of peace and reconciliation and framing them within official and unofficial institutions.

Expanding the culture of reconciliation in the Palestinian society in Gaza.

Benefit from the graduates of this program in the development of reconciliation practices.

Strengthening local competencies in the issue of reconciliation through building institutions and capacities is of vital importance to the beneficiaries of citizens and officials.

Peace building interventions aim to strengthen the state in order to create strong and legitimate political system.

Strengthening the ability of political parties to participate in electoral processes in ways consistent with the principles of a democratic system.

Organizing more targeted training to cover specific topics including, but not limited to, transitional justice, electoral processes, human rights violations, refugee reintegration, reconciliation, and gender sensitivity.

On the economic front

Civil society is seen as a vital sector in peace building and the master's program in peace studies at Al-Azhar University comes within this framework. Many parties can benefit from this program, and we can mention many of these institutions, to name a few, including:

- 1. Institutions of the Palestine Liberation Organization
- 2. Department of Palestinian Refugee Affairs
- 3. Local human rights institutions
- 4. Political parties
- 5. Local civil society organizations

The program qualifies graduates to obtain a wide range of careers in international affairs, from local governance to foreign affairs, to international development, to human rights, global

communications, and many other areas that involve interaction with different countries and cultures.

Graduates of the Master's Program in Peace Studies and Reconciliation will have the possibility to work in various governmental and non-governmental institutions, Palestinian governmental institutions, Arab League institutions, international institutions, and educational institutions (such as higher education institutions and scientific research institutes). Graduates can work in think tanks and scientific research.

Based on these data, the relationship between the graduates of the program and the labor market was studied, and the extent to which the market was able to absorb the graduates of the program and directly benefit from their scientific and practical experiences was confirmed.

We expect the program to include a wide range of political, developmental, humanitarian and human rights applicants. This requires short and long-term actions designed to meet the special needs of the Palestinian community. This
